THE LANDMINE CLEARANCE TEAMS PROACTIVELY CLEAR LAND KNOWN TO BE CONTAMINATED SO THAT IT CAN BE USED PRODUCTIVELY FOR FARMING AND COMMUNITY ACTIVITIES. IN ADDITION, THE CLEARANCE TEAMS REMOVE UNEXPLODED ORDNANCE NEAR SCHOOLS, COMMUNITY CENTERS, HOMES, AND OTHER PUBLIC PLACES BY RESPONDING TO REPORTS RECEIVED THROUGHOUT THE YEAR. A TOTAL OF 11,002 ITEMS OF UNEXPLODED ORDNANCE WERE REMOVED IN 2010, COVERING 182 ACRES OF CLEARED LAND.
